Theses licenses include authorization to use designated marketing materials in alignment with these guidelines.²

To maintain the value of our licensed materials and to help protect the value of your certification, please follow these guidelines for using AIW intellectual property.

# How is IP protected?

Intellectual property is protected both by our license agreement and under Copyright and/or Trademark Law – and it's protected internationally. What does that mean?

**License Agreement** is our terms and conditions for doing business and was completed by each person who invested in our program. You can see a copy of our license agreements on the WISDOM Coach™ Website.

**Copyright** is a form of legal protection given to the authors or creators of "original works of authorship," to determine use of that work. This includes:

- making copies of the work;
- distributing copies of the work;
- performing the work publicly (such as for plays, film, dances or music);
- displaying the work publicly (such as for artwork, or stills from audiovisual works, or any material used on the Internet or television); and
- making "derivative works" (including making modifications, adaptations or other new uses of a work, or translating the work to another media).

**Trademark** is a form of legal protection given to the creators of a "source identifier," (these are also referred to as logo marks or word marks – think the Nike swoosh for a logo mark or the name Nike for a word mark) to determine use of that logo or word mark. This includes:

- displaying the mark;
- advertising goods/services using the mark;
- licensing the use of the mark for a fee;
- preventing others from using the mark.

In general, it is illegal for anyone to do any of the things just listed without the permission of the intellectual property owner – in our case either Adventures in Wisdom™ or Renaye Thornborrow.

Permission will vary based on whether the work is part of our AIW Curricula or part of our AIW Marketing Collateral.



# Why is it important that we protect our intellectual property?

## For quotes use something like:

For passages of text, such as a section from our special report, either before the text or immediately following the text, display the following reprint statement:

# Using Adventures in Wisdom ™ Messaging on your Website

Please follow the same guidelines shared under Adventures in Wisdom™ Marketing Collateral. When quoting from our materials, always cite source. When using messaging from our collateral such as the Special Report, always cite source with permission to reprint.

When presenting descriptions of your services that are using our work, always share that you are using Adventures in Wisdom as part of your coaching/workshop services before presenting the packages:

- My coaching packages [workshops] are based on Adventures in Wisdom™.
- I am a certified WISDOM Coach<sup>™</sup> and I'm sharing a story/tips/a process/ from Adventures in Wisdom<sup>™</sup>.
- I am a certified WISDOM Coach™
- I use the WISDOM System for Coaching Kids by Adventures in Wisdom™
- My programs [workshops] are based on Adventures in Wisdom™
- I use stories from Adventures in Wisdom in my workshops [coaching]

# Using the AIW Articles Provided as Part of Your Certification

The articles we have licensed you to use as part of your nurture program must be used in their entirety, must not be modified and must maintain authorship and copyright.

You CAN add your own commentary and promote your business *in a resource box* that appears at the end of the article.

A Resource Box is a call to action that you include at the end of the article to ask the reader to do something (usually a link to your website). It is also the place where you can say something about yourself and your credentials.

Here is an example of what the article might look like. The resource "box" is the language in green italics:

# Writing articles

We know our WISDOM Coaches come from a variety of backgrounds and have your own areas of expertise. You are certainly authorized to write your own articles; however, when writing an article, it must be mostly your own material with very limited use of AIW copyrighted material. When referring to something from Adventures in Wisdom™, you must give attribution to the author.

## Tele-classes and Webinars

You are only licensed to teach/use Adventures in Wisdom™ materials is LIVE with your clients. This does include conducting **LIVE** tele-classes and webinars.

Our work may not be recorded and integrated into any type of information product that is given away or sold.

# Creating YouTube/Facebook/Social Media-type Videos for Marketing

It is becoming increasingly common for licensees to create videos for use as part of their *marketing efforts*.

If you will be making a video to promote your coaching or workshops and you are using any of our content, then you must *clearly indicate, up front, that your video is a preview of what one* will learn in your class AND that you are using materials from Adventures in Wisdom™.

Those videos should be limited to a very brief discussion of a module or skill (i.e. less than 5 minutes).

Not citing source at the beginning of the video is representing the content as your own and is misuse of our intellectual property.

### Here are a few guidelines:

 When using our content, always credit source before presenting information. Citing source is not only a professional courtesy it is also requirement of our intellectual property use guidelines.











Citing source also brings credibility to the information you are providing, and honors authorship and copyright laws.

Here are some options for doing that:

- a. "I want to share some tips with you from Adventures in Wisdom – I am certified to present their work [or I am a certified WISDOM Coach]."
- b. "Here are some tips from Adventures in Wisdom where I completed my certification."
- c. "Today I plan to share tips from the Adventures in Wisdom skill book on Managing Mistakes."
- d. "I wanted to share some information with you from Adventures in Wisdom and I've added my touch as well...."
- e. "I am a certified WISDOM Coach and I wanted to share some of the tips that we use when coaching kids."
- When thinking about including our content in a recording, a good guideline to remember is that you can share what and how you help kids but avoid including the actual teaching itself.

For example, you could share that you use the story, *Weight of Mistakes*, to teach the five I's of managing a mistake. However, don't teach the Five I's or share the story itself.

However, don't teach the Five I's or share the story itself.

3. Another example is that you can share the messaging from our Adventures in Wisdom™ Message Makers that frame the problem/topic and share the name of the story that you use to help kids develop a specific skill.

Here is an example:<sup>4</sup> [From skill book 1]

"One of the things I teach with Adventures in Wisdom™ is the power of belief systems and how your mind shapes your world.

Just like a plane can take us where we want to go on a vacation, our mind takes us where we want to go in life. Kids learn that our mind has two parts, our conscious mind

which acts like our pilot – controlling our "plane" with thoughts and our subconscious mind, which acts like our autopilot – controlling our "plane" based on the "programs" it is running. These programs are called belief systems and they either support us in creating what we want in life or they limit us at every turn. Understanding and creating supportive belief systems is critical for reaching our full potential, creating a happy life, and achieving our goals.

The Adventures in Wisdom story we use to teach this skill to your children is called, Who's Flying Your Plane? As part of the lesson, we do a fun paper airplane activity to help children see how supportive beliefs and limiting beliefs shape their lives."

## Using Wyatt the Wise Wizard™

Wyatt the Wise Wizard is a symbol of our brand and he must never be renamed or changed. If you are presenting to a community who does not like the concept of wizards, you may shorten his name and just use "Wyatt" or "Wyatt the Wise". Please be sure to include ™ with any mention of his name and/or use of his image.

Wyatt the Wise Wizard is a wizard. You may not change him into a different character such as an animal or other representation.

You may not write stories using Wyatt the Wise Wizard as a character. He is an Adventures in Wisdom trademark and should only be used in materials authored by Renaye Thornborrow.

Think in terms of Dr. Seuss or Harry Potter. You wouldn't be authorized to rename their characters or write stories using their characters.

## Facebook/Twitter/Social Media Posts

You have our permission to *repost* any of our social media posts to your own community (feel free to add your own commentary as part of the "share" feature). However, you do not have our permission to copy our posts and post them as your own.

Also, if you use any of our quotes, or tips you must cite source as being "Adventures in Wisdom".

When choosing content, a good guideline to remember is that you can share *what* and *how* you help kids but avoid including the actual teaching itself.
